## **CHURCH CONSTITUTION (Pastor Steve)**

- Pastor Steve has proposed edits to align Immanuel's constitution with the 2022 model constitution.
- Additional work is required to ensure alignment with ELCA 2025 model constitution, which was just updated this week.
- The most significant proposed change is allowing for the office of the Deacon. Other changes are relatively minor.
- Approval steps for updating the constitution:
  - (1) Approve edits by the council (today)
  - (2) Review by the Synod and adjust if needed
  - (3) Approval by the Synod
  - (4) Congregational forum plus two meetings to vote (one to approve, and one to ratify). Since we deviate from the model in some cases, we need a  $\frac{2}{3}$  majority vote.

**MOTION:** Jim A. moved to approve the constitution as amended, with the adjusted language to 11.0.3., Lou H. seconded. Amanda abstained due to arriving late, and everyone else voted to approve.

## **CALL COMMITTEE UPDATES (Kim W.)**

 The call committee anticipates two interviews with Pastor Dan, and has scheduled the first one for the first week of October.

## **MEMORIAL POLICY APPROVAL (Kirsten S.)**

• The memorial policy will establish a committee to report to the Financial Secretary and assist in managing memorial giving and purchases.

**MOTION:** Kim W. moved to approve the new Memorial policy as written. Eric seconded, and all voted to approve.

#### ATTENDANCE AND FINANCIAL UPDATES

## Attendance - Rick I.

- August had the highest in-person attendance percentage for the year.
- We had the highest attendance for a 12-month period since 2021.
- Attendance has been rising for 4 years in a row.
- Pastor Steve mentioned that continued strong attendance after the retirement of a beloved pastor is a strong indicator of a healthy congregation.

### Giving - Rick I.

- Looking at a 12-month rolling period, we are about \$28,000 lower than the previous 12 months.
- Based on analysis of 12-month rolling periods, giving seems to be trending downward.
- Rick I. and Jim A. are planning Temple Talks to help shore up giving.
- We had some discussion about whether Amplify migration has affected giving, but Kelly M. shared that everyone has been successfully migrated.
- Kelly M. offered to pull some reports comparing pledges with giving.
- Pastor Steve suggested including a letter with the 3rd quarter giving statements.

#### Financial Statements - Kirsten S.

- Expenses are easier to predict, but lower Income makes it look worse.
- We are over budget in benevolence and building, and under budget for personnel.
- We expect to be over budget in utilities this year, so we will need to consider this when budgeting for 2026. Need to consider 3 years prior instead of 1 when budgeting.
- Kelly M. suggested committees take the time to look at their departmental reports through August, and ask for additional details if they have questions about any numbers. Pay attention to monthly differences in expenditures as you plan your budget for 2026.

### **VOLUNTEER MEMBER ENGAGEMENT (Tom G.)**

- Tom will engage with the nominating committee. Trying to get out ahead of it.
- The nominating committee will reach out to people ending their first term to see if they are interested in serving a second term.
- Adjustments to the Bylaws are in progress and will likely be proposed at the next meeting.

## **WELCOME WEEKEND (Amanda R. and Pastor Dan)**

- It may be a little light in volunteers, but they seem to be filling in.

## Adult Faith Formation - Jennifer J.

### Parish Fellowship - Bev O. / Ruth L.

- Extensive planning/preparations are underway for the Sunday picnic that follows the Tent worship service, Welcome Weekend. Efforts are being made to recruit enough volunteers. A grill was purchased, which is an improvement over what was a rented grill in previous years.
- Planning is underway for Wednesday Cafe, which begins Sept 10. We are still trying to find a leader for the team that earlier was led by Karen Nelson. We also need more volunteers for each of the four teams.
- Working on getting volunteers to serve Beverages on Sunday mornings (coffee, lemonade, etc) and to provide Treats.
- Planning is underway for the Smorgasbord, which will be Friday December 5th.
- After a review of electrical, two heavy duty extension cords were purchased, which are important when there are large food events at Immanuel.

### Social Ministry - Kelly R.

- We are planning a Game Night for November 1 (after trunk or treat) as a benefit for Cristo
  Obrero. We will have beverages there from the Lions Club, Everything Bundt Cake, and Hot
  Dog dinners for sale (all proceeds will go to CO). We are hoping to do a match for donations as
  well with S+J funds designated for Immigration but that is TBD
- We updated committee job descriptions
- We just started the process of creating a ministry assessment tool as the next step in being intentional and strategic in the ministries and champions we partner with. An "intake" form/process will be the next initiative.
- Survey results will be a part of the annual report. We also requested they be a part of Stewardship month
