Survey to congregation- what did we do well, what could be better, how can we reengage now that we are opening back up? Are we meeting the needs of our congregation as we are trying to get back to normal? What concerns do you have before returning to church? Council, re-opening committee and staff to review responses. Send out before end of June, give a couple of weeks to respond. Report back in August. In July we will need a committee to analyze the data.

## New Business:

Salary increases- in the budget for 2021 was a 3% increase to look at mid-year. Tami, Paul and Tony will discuss in July and reach out to the executive committee if needed.

Tammy V.- replacing windows in sanctuary- the bottoms are rotted out- The crank out mechanism falls out. Got 2 bids for window replacements. Just under \$40K to replace all windows that open. Could be less if we go with aluminum windows that don't all open. Motion to approve up to \$40K to replace the lower ground level (113 3/8" x 31  $\frac{1}{2}$ ") windows in the sanctuary out of the building fund. 1<sup>st</sup> Jessica 2<sup>nd</sup> Pastor Paul. Motion Passed.

Strategy- This has been finalized. Mid-year meeting in September. We need to activate groups to cover each of the strategies. We will include council, staff and congregation members in each group.
